On the 3rd of September, 2018, the Anti-Ragging Committee and the Internal Complaint Committee of our institution jointly organized a program focused on "Women's Safety and Laws." The event was a great success in raising awareness about women's safety and the legal safeguards available to them, encouraging a sense of responsibility among students to create a safer campus environment.
